entire life of, but many are losing a significant sum of money in the process. Due to government mandated shutdowns across the country venues, catering companies, and entertainment companies have been forced to cancel their services, leaving the couples in a scramble to find replacements. Often, venues, such as my employer, have a clause which ensures that during an "act of God" like the COVID-19 pandemic, the company is not responsible nor required to issue a refund to the clients.
