Dear Pit River Tribal Members and Visitors,

After careful consideration, the Pit River Tribal Chairperson has made the decision to **close our site offices to the public** due to the increasing concerns related to the COVID-19 virus. This includes cancelling all in person meetings and not allowing anyone besides employees inside of any of our buildings as “social distancing” is the best practice to mitigate exposure.

This decision is not to create additional concern but is a proactive measure to protect our staff, tribal members and other community members. Until these limitations have been lifted, all paperwork can be accepted or sent via fax, mail, or email.
