## FACTS AND TRUTH OR "FACTS" AND "TRUTHS"

Oh, my gosh – who knows? I certainly don't. I just report on what I read, hear and see with as many journalistic filters and cross checks as I can muster. Let's start off with some input from a couple of HH loyal readers.

One reader points out that I have been snookered by virtually all of the press (Blue and Red), Biden is NOT the president elect, he is the presumptive president elect. Presumptive, because there are legitimate challenges in progress which, if upheld, could deny Biden the presidency.

Another reader adds input from Pam Bondi who was Florida AG from 2011- 2019.(a big Trump supporter). Bondi points out that Gore was called president elect for 30 days in 2000 until the courts ruled against him and declared Bush the winner.

Bondi goes on to note that SCOTUS could either rule that all improper ballots, due to fraud or mistakes, be removed and recounts made, or, that the election is invalid due to massive voter fraud (unsubstantiated at this time). In case the election is declared invalid, the congress votes on who becomes president (Senate votes on the Vice President) and each state has one vote. There are 30 Republican states and 19 Democratic states. Here, Ms. **Bondi is incorrect according to Reuters Legal** News feature "Explainer" which advises there are 26 Republican delegations, and 22 Democratic. One delegation is split evenly and the remaining one, comprised of 7 Democrats, 6 Republicans and one Libertarian. This is all covered under the 12th Amendment to the Constitution. If for any reason the House has not declared a president by January 20<sup>th</sup>, the Speaker of the House would serve as acting president.

In any event, even reaching the Supreme Court seems unlikely today, as it is widely reported in the NY Times and other news services that election officials nationwide have found no fraud. But wait a minute – "election officials" make that statement? Isn't that like the fox checking on the chicken coop?

Let's look at Georgia, Arizona, Wisconsin, Nevada and Pennsylvania the president is behind by about a total of 120,000 votes. The important thing is what votes are being contested in each state. Face it, when it comes to elections, people have been gaming the system from the earliest days.

Trying to pull everything together and come up with a consensus of what the media is reporting; yes, we are seeing scattered allegations of voter fraud, but these reports seem of no consequence against the totality. What could, of course, change that would not be fraud, per se, but improperly observed counting such as alleged in Pennsylvania. In any event, as discussed in the last issue,

Trump's team has every legal right to pursue all these avenues prior to conceding. This is an uncomfortable, but by no means unique process. In reflection of all this confusion, a Morning Consult poll reflects that seven out of ten Republicans, "doubt that the 2020 election was, 'free and fair'".
